***Air Services shall be commenced within a period of twelve months. Failure to comply with this Condition shall cause the automatic termination of this licence.***

***This licence is issued subject to the condition that should any change in the shareholding structure of the group of controlling companies be contemplated, the licensee should apply to the International Air Services Council for approval of that contemplated change.***
